The Government of Sindh is implementing Sindh Irrigated Agriculture Productivity Enhancement Project (SIAPEP) with financial assistance of the World Bank under IDA Credit No. Cr.5604 Pak aims to improve water and agriculture productivity for small and medium size farmers in Sindh. A part of the proceeds of this credit will be applied to eligible payments under the contract for Procurement and Installation of IT Equipment.
2. The Government of Sindh through Project Director, PIU of Sindh Irrigated Agriculture Productivity Enhancement Project, Agriculture Department, now invites sealed bids from eligible bidders for the supply and installation of following equipment:

6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Documents: Procurement of Goods for National Competitive Bidding, Pakistan*, Part One. Procurement shall be done through

National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of Guidelines Procurement of Goods, Works, and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011).

7. A pre-bid meeting will be conducted on **25 January 2016 at 2:00 pm** in the office of PIU – SIAPEP as mentioned below. All potential bidders are invited to attend the pre-bid meeting.
8. Bids must be delivered to the above office on or before **12:00 Noon on 08 February 2016** and must be accompanied by a security of 2% of the bid amount in favour of Project Director, PIU, Sindh Irrigated Agriculture Productivity Enhancement Project.
9. Bids will be opened in the presence of bidders' representatives who choose to attend at **12:30 pm on 08 February 2016** in the offices of Project Director PIU on below mentioned address.
10. The bidders are requested to give their best and final prices as no negotiations are expected.
11. All bidders shall be required to submit with their bid, information on their eligibility and qualification as per the Bid Data Sheet included in the bidding document.
